SUBJECT: **California's Severe Drought and Conejo Recreation and Park District's Response in Terms of Water Conservation Recommendations**

On May 7, 2015, the Board directed staff to provide monthly reports of the District's water use, water savings projects, and activities to date.

  - Convert to Reclaimed Water at North Ranch Neighborhood Park
    - ◆ Completed
    - ◆ Submitted for reclaimed water conversion rebate
  - Irrigation Booster Pump Replacement at Conejo Creek South
    - ◆ Completed
  - Convert Small Turf Areas to Decomposed Granite, Mulch, Concrete at Wildflower Playfield
    - ◆ Turf rebate application approved (NTE \$21,500)
    - ◆ Project completed and rebate funds received
  - Additional Turf Conversions at Conejo Creek West (Dog Park)
    - ◆ Turf rebate application approved (NTE \$50,000)
    - ◆ Project completed and rebate funds received

- Hiring Irrigation Technician
  - Started mid-September 2015
- Modifying Turf Refurbishments
  - Ongoing
- Turf Conversions
  - Water shut-off at all locations, approximately 40 acres
  - Turf rebate applications
    - ◆ 9 parks completed and approximately \$305,600 rebate funds received
  - Metropolitan Water District has provided approval for additional parks (balance of parks from prior wait list) for turf removal incentives.
    - ◆ 29 parks total
    - ◆ 8 months to complete (end dates Feb – March 2017)
    - ◆ Approximately \$870,000 in potential rebates
    - ◆ Projects to be completed by FS Construction, Senel Construction and Engineering (result of recent RFP process) and United Landscaping to meet grant deadlines
      - 1 Park (Estella) completed, rebate submitted and approved (\$11.7k)
      - 9 parks (Waverly, Conejo Creek North, North Ranch Neighborhood, Newbury Gateway, Stagecoach Inn, Wildwood Neighborhood, Kimber, Oakbrook Neighborhood, Spring Meadow) completed and rebate submitted
      - 19 parks to do
- Waiver for Watering Operations
  - Approved for all three water agencies

  - On-site signage for turf conversions, modified field refurbishments

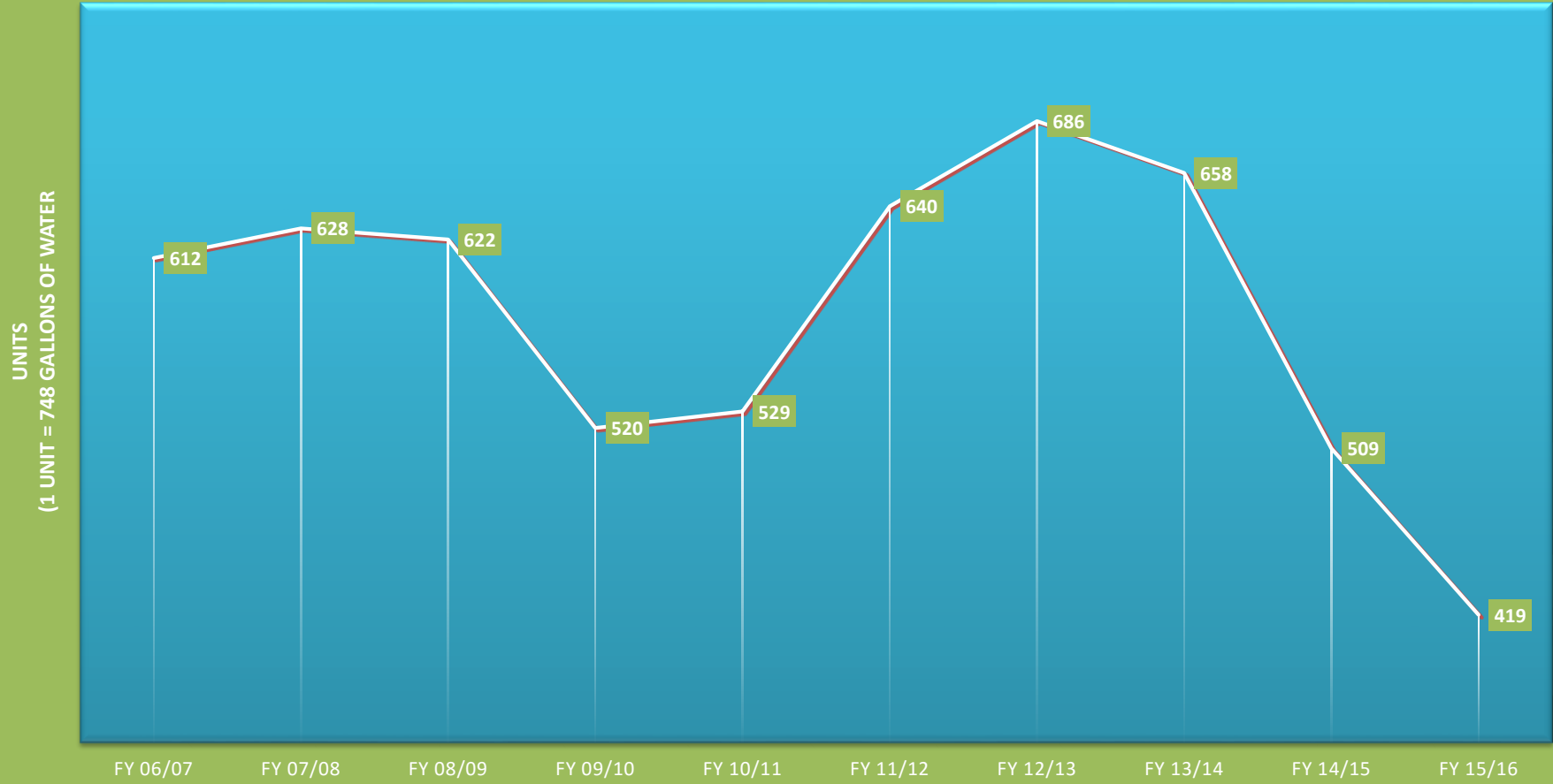

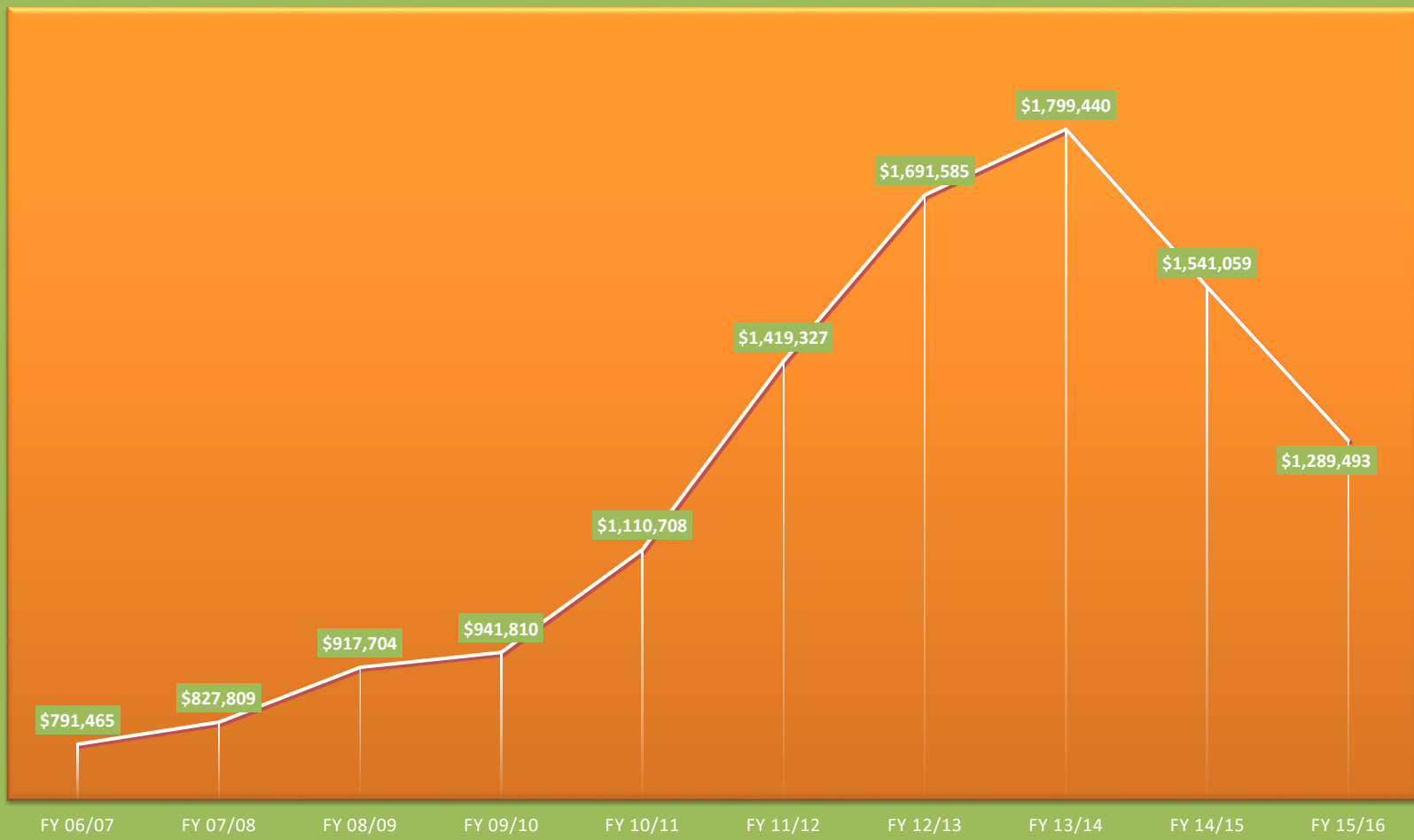
