Response in Terms of Water Conservation Recommendations

On May 7, 2015, the Board directed staff to provide monthly reports of the District's water use, water savings projects, and activities to date.

Water Use

Attached is the monthly water use report, including:

- Water use from June 1, 2015 to January 2017 as compared to same months in 2013 (by Districtwide, and by water agency)
- District's Water Usage per Acre (All Funds)
- Overall Water Costs (All Funds)
- Rainfall

FY 2016/2017 Water Savings Projects and Activities

- Capital Projects
 - Drought Response Irrigation Improvements and Turf Conversions Districtwide
 - ◆ 26 parks approved by Metropolitan Water District (MWD) for turf rebate funds in the amount of \$720k
 - 8 park completed and rebate funds received (\$175k) from MWD
 - 1 parks completed and approved for rebate funds by MWD
 - 13 parks completed and submitted to MWD for approval for rebate funds
 - 2 parks work is in progress
 - 2 parks to schedule
 - Investigate/Develop Conversion to Reclaimed Water at Triunfo Community Park
 - ◆ Turf rebate application approved (NTE \$50k)
 - ◆ Project out to bid in October 2016

- 4-6 Pickleball Courts and Turf Conversion at Rancho Conejo Playfield
 - ◆ Turf rebate application approved (NTE \$50k)
 - Project construction start December 2016
- o Master Plan Development and Turf Conversion at Banyan Neighborhood Park
 - ◆ Project out to bid Spring 2017
- Phase 3 Development and Turf Conversion at Northwood Neighborhood Park
 - ◆ Turf rebate application approved (NTE \$50,000)
 - ◆ Project out to bid October 2016
- Modifying Turf Refurbishments
 - Ongoing
- Waiver for Watering Operations
 - Approved for all three water agencies
- Public Outreach
 - Website updated information, maps of turf conversion areas (www.crpd.org/water)
 - o On-site signage for turf conversions, modified field refurbishments
