**SUBJECT:** California's Severe Drought and Conejo Recreation and Park District's Response in Terms of Water Conservation Recommendations

On May 7, 2015, the Board directed staff to provide monthly reports of the District's water use, water savings projects, and activities to date.

## Water Use

Attached is the monthly water use report, including:

- District's Water Usage per Acre (All Funds) from Fiscal Year 2008/2009 to Fiscal Year 2018/2019 (to date and projected),
- Overall Water Costs (All Funds) from Fiscal Year 2008/2009 to Fiscal Year 2018/2019 (to date and projected),
- Rainfall to date from Fiscal Year 2008/2009 to Fiscal Year 2018/2019 (to date).

## FY 2018/2019 Water Savings Projects and Activities

- Capital and Major Repair Projects
  - Annual Drought Response Irrigation Improvements and Turf Conversions – Districtwide
    - ◆ Projects completed at ten parks; two parks in progress/planning.
  - Annual Master Flow Valve Installations – Districtwide
    - ◆ Projects in planning stage at multiple parks
  - Replace Irrigation System at Main/Maids House at McCrea Ranch
    - ◆ Estimated construction completion in April 2019
  - Irrigation Replace/Upgrade at Thousand Oaks Community Park
    - ◆ Project completed August 2018
- Modifying Turf Refurbishments
  - Ongoing

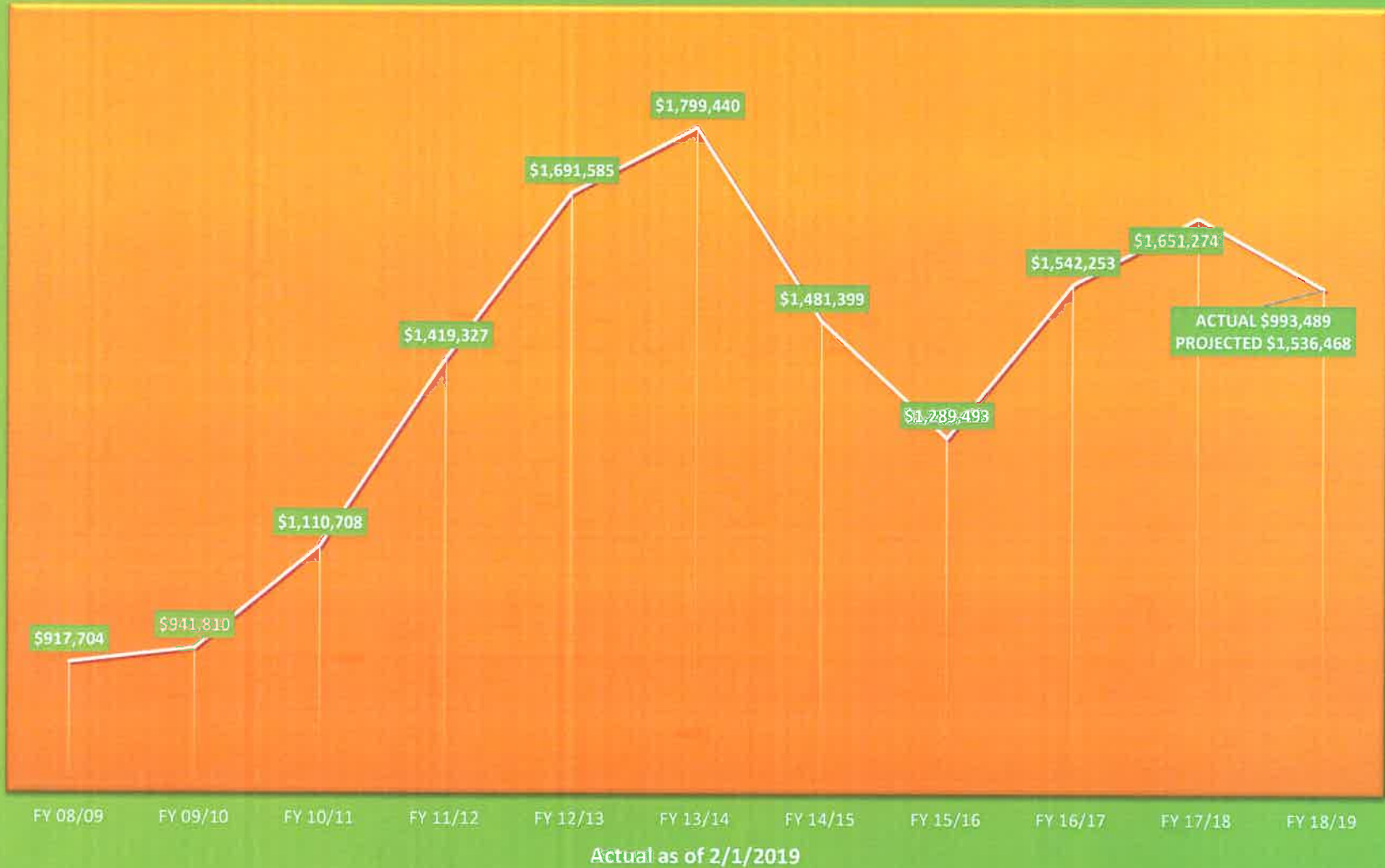
