**SUBJECT:** California's Severe Drought and Conejo Recreation and Park District's Response in Terms of Water Conservation Recommendations

On May 7, 2015, the Board directed staff to provide monthly reports of the District's water use, water savings projects, and activities to date.

## Water Use

Attached is the monthly water use report, including:

- District's Water Usage per Acre (All Funds) from Fiscal Year 2009/2010 to Fiscal Year 2019/2020 (to date and projected),

- Rainfall to date from Fiscal Year 2009/2010 to Fiscal Year 2019/2020 (to date).

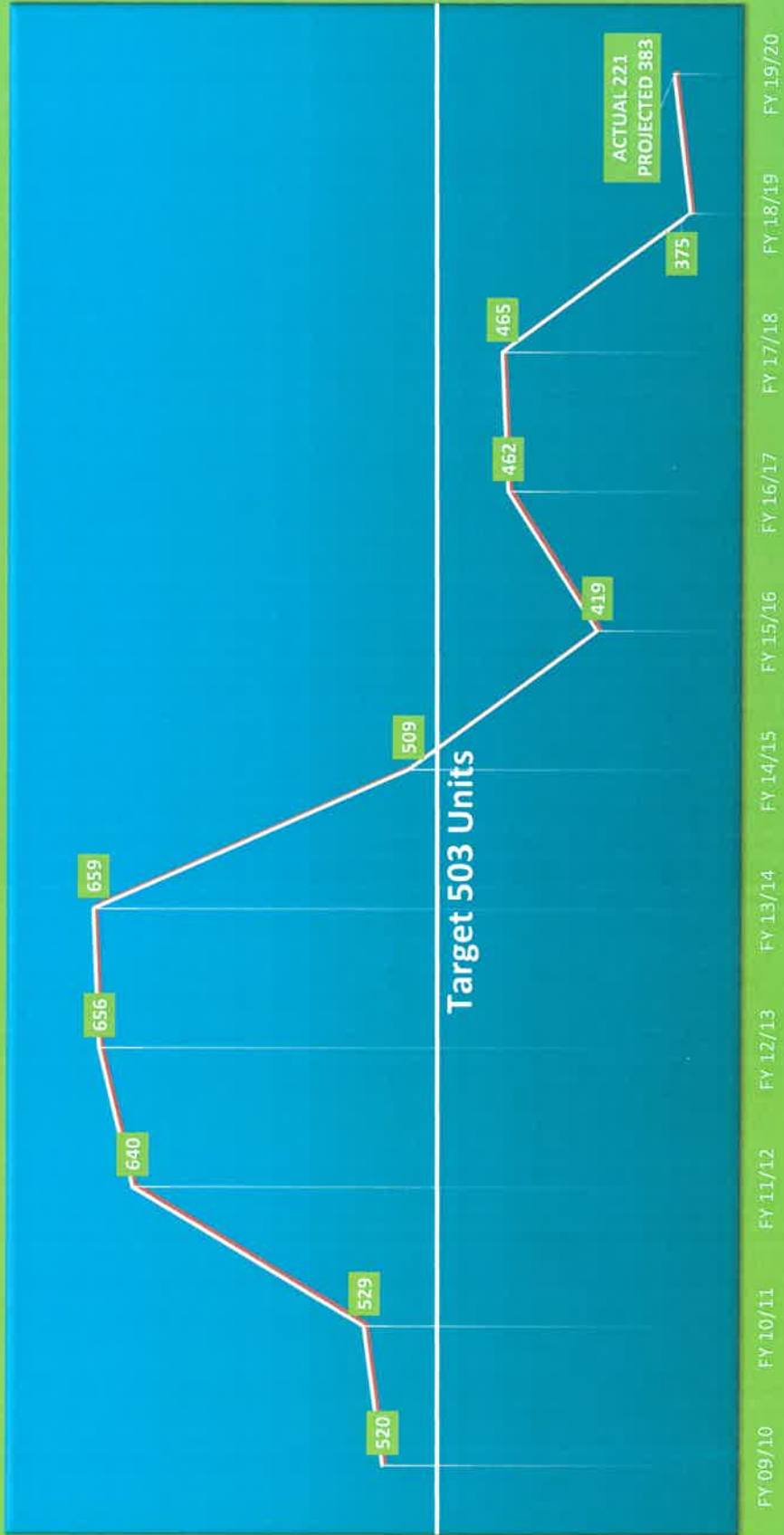

# CONEJO RECREATION AND PARK DISTRICT WATER USAGE PER ACRE (ALL FUNDS)

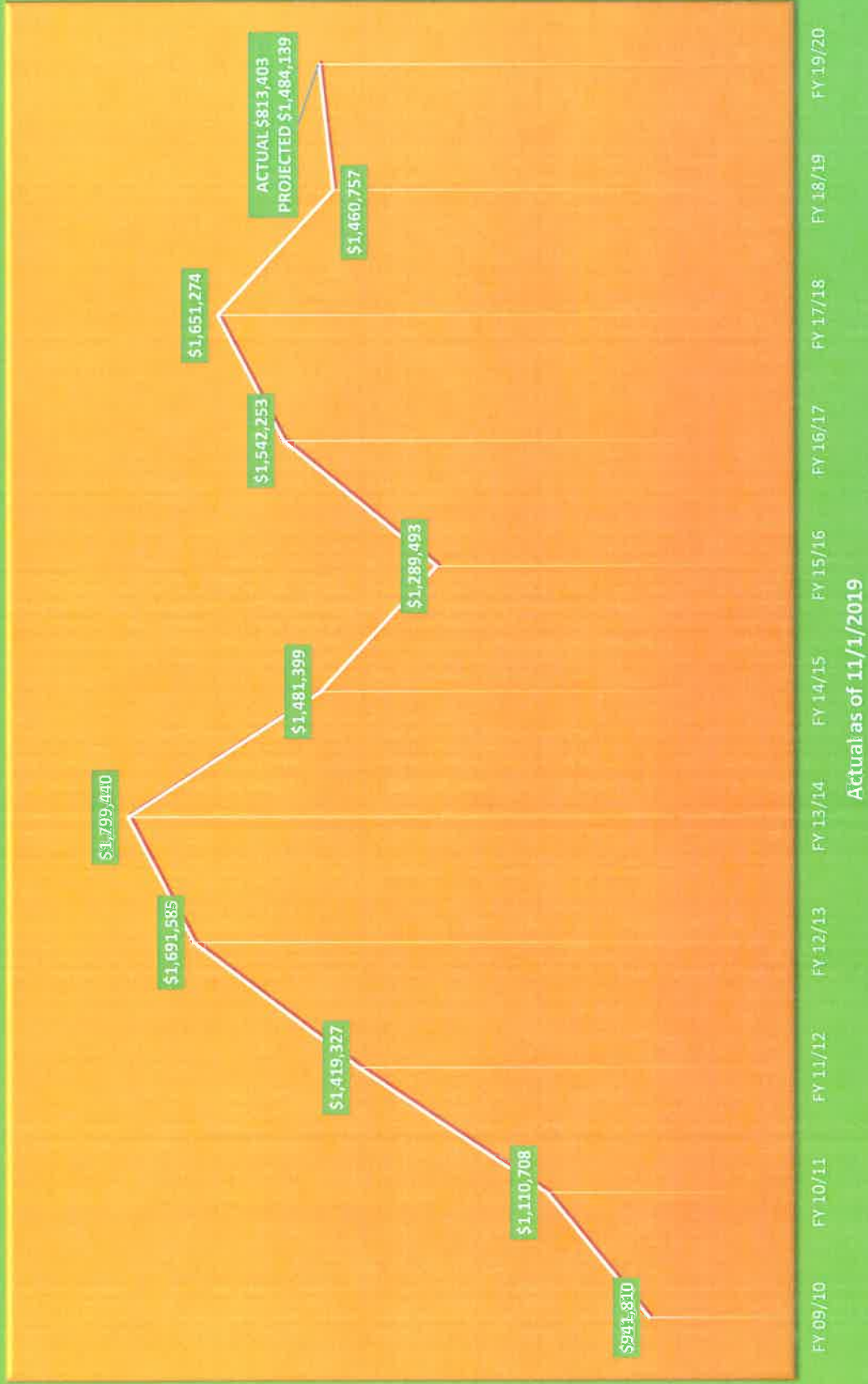


Target 503 Units
