SUBJECT: California's Severe Drought and Conejo Recreation and Park District's Response in Terms of Water Conservation Recommendations

On May 7, 2015, the Board directed staff to provide monthly reports of the District's water use, water savings projects, and activities to date.

Water Use

Attached is the monthly water use report, including:

 - Ongoing

 - Website updated - information, maps of turf conversion areas (www.crpdc.org/water)
 - Signage regarding CRPD water conservation efforts placed at every park

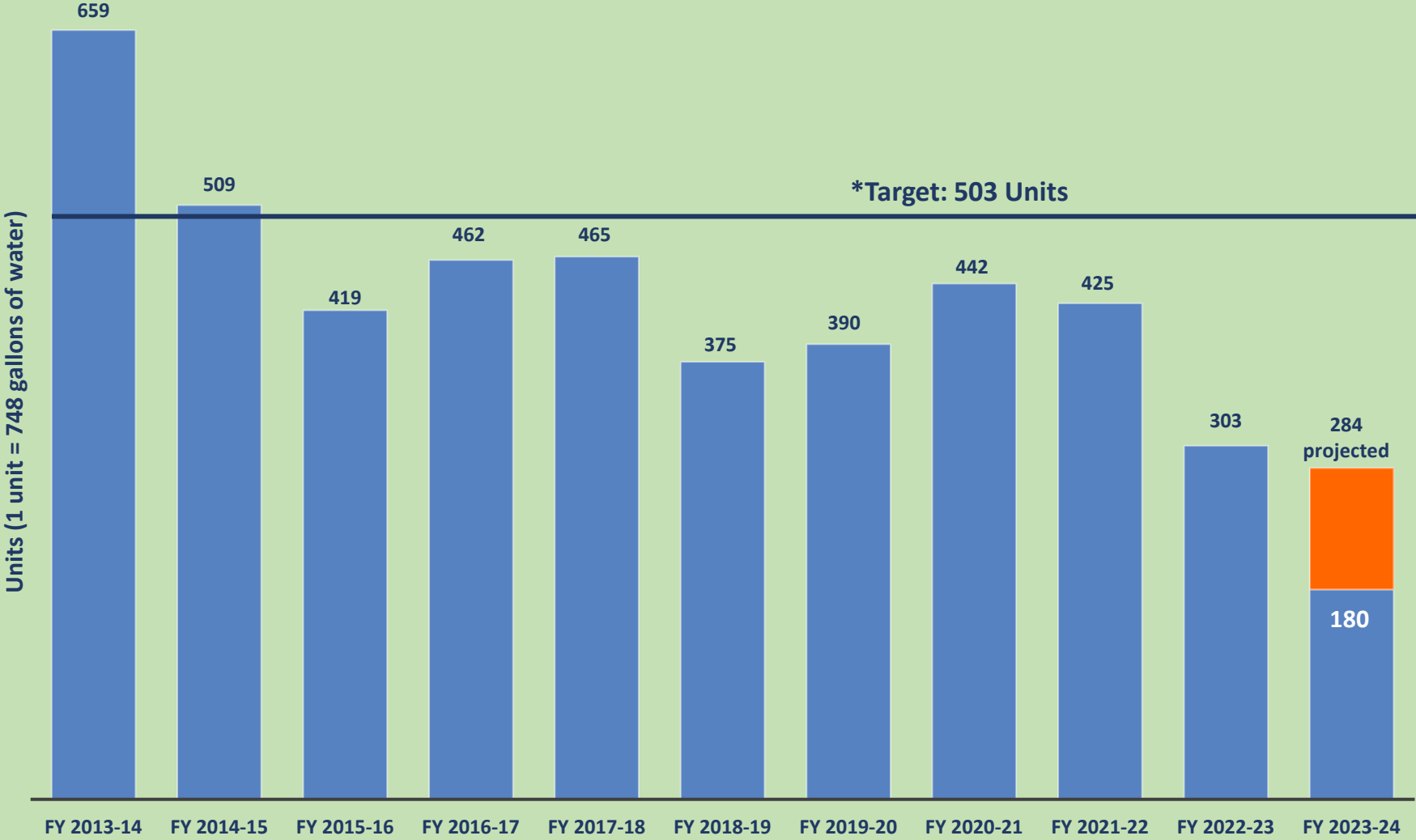

Water Usage Per Acre (All Funds)

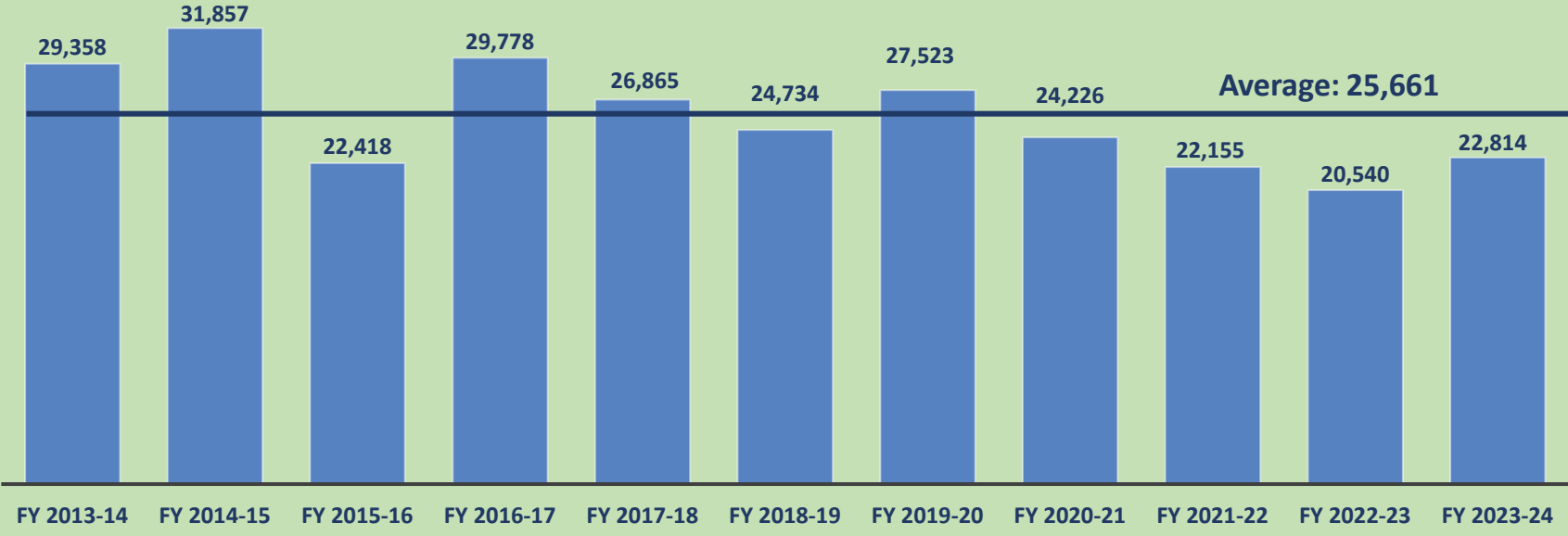

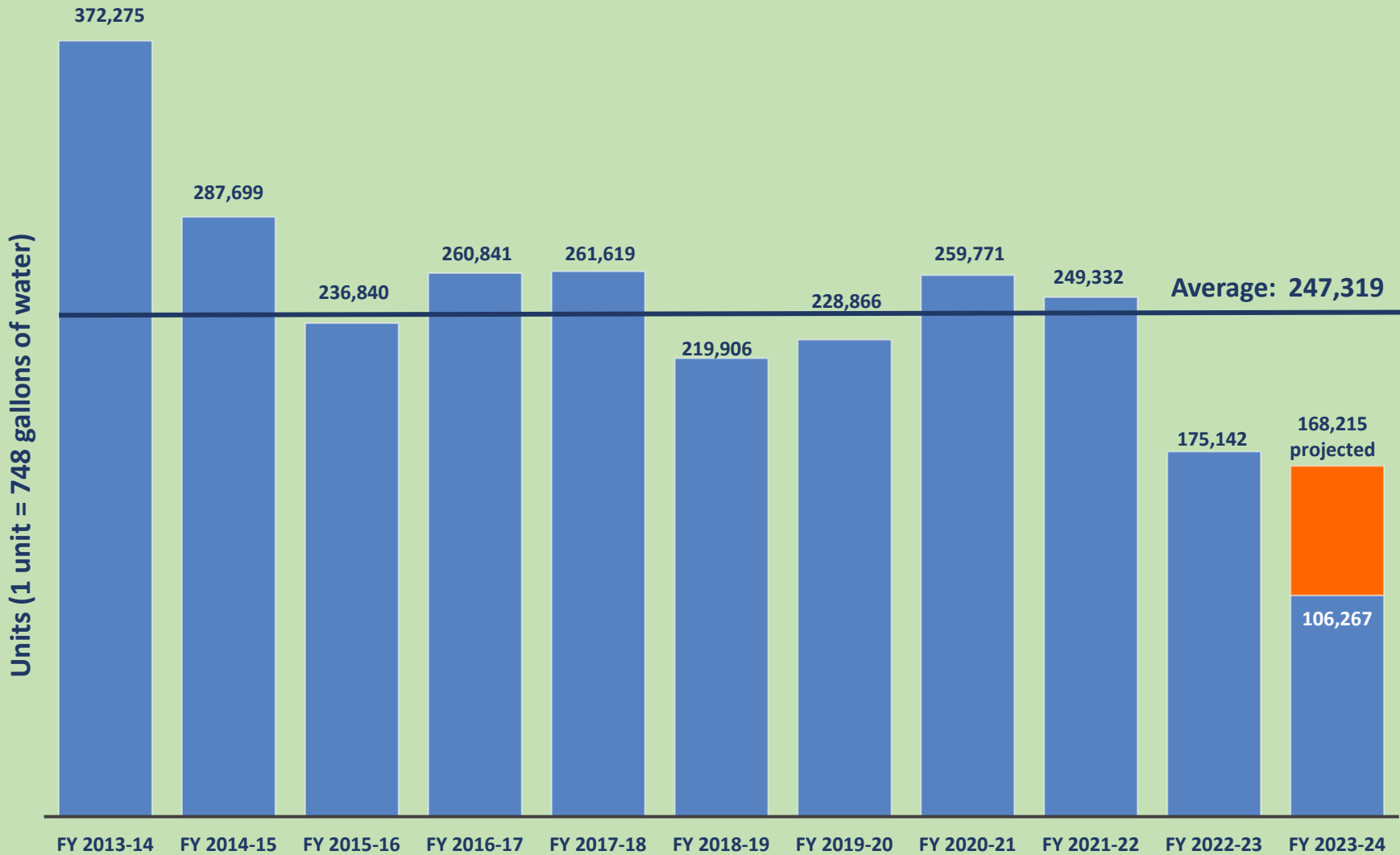
Historical Water Usage for October

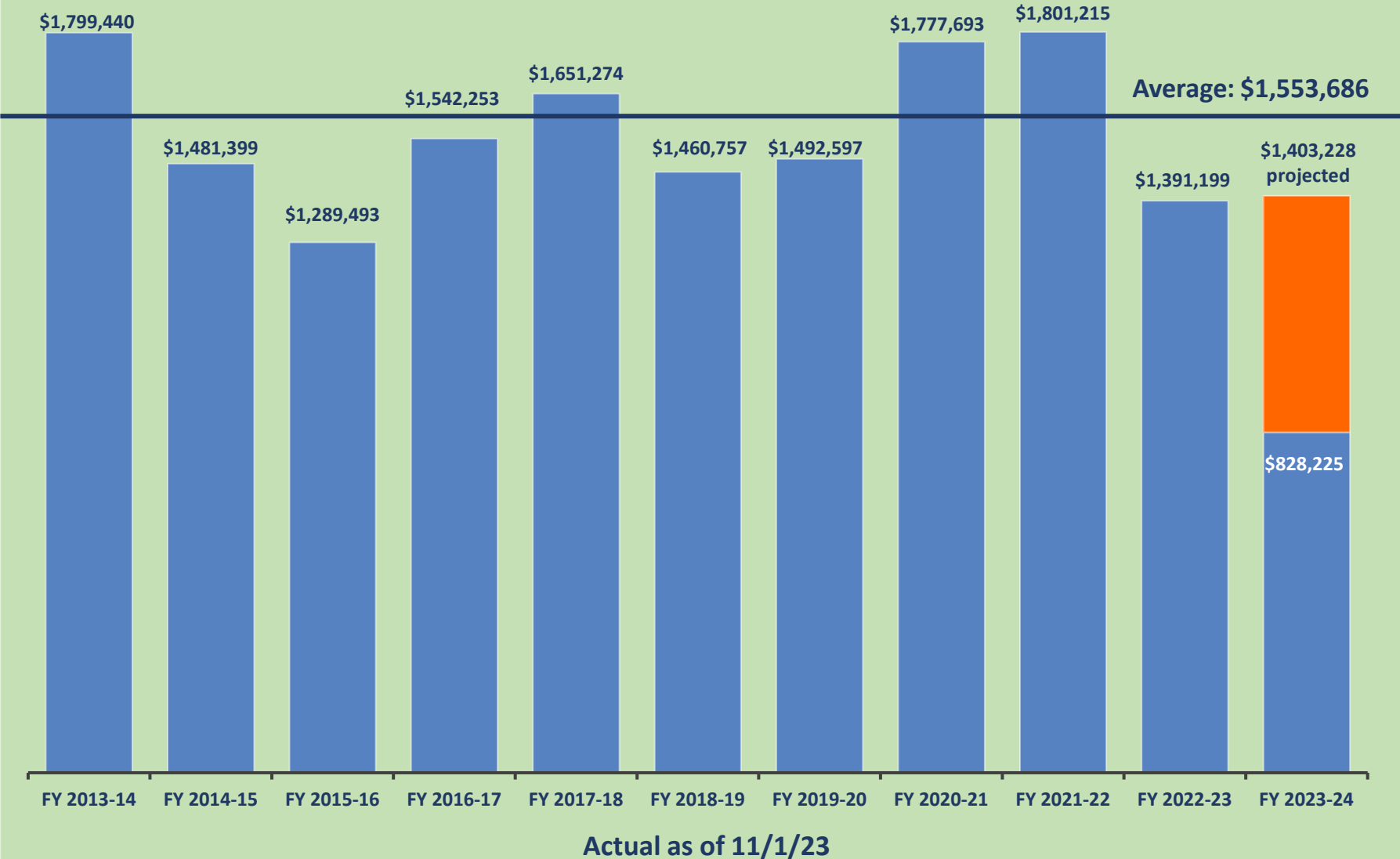
Historical Water Usage By Fiscal Year
