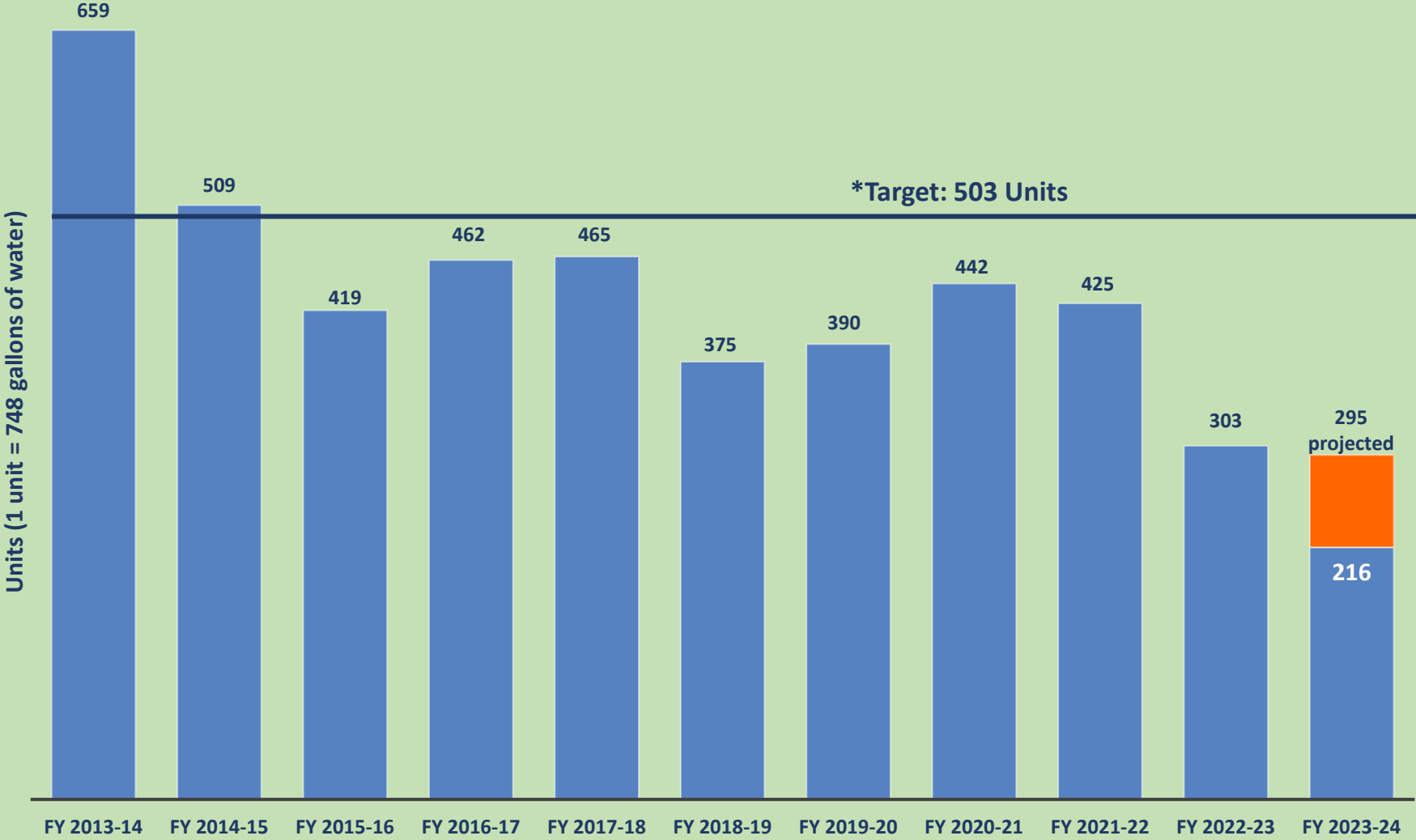

Water Usage Per Acre (All Funds)



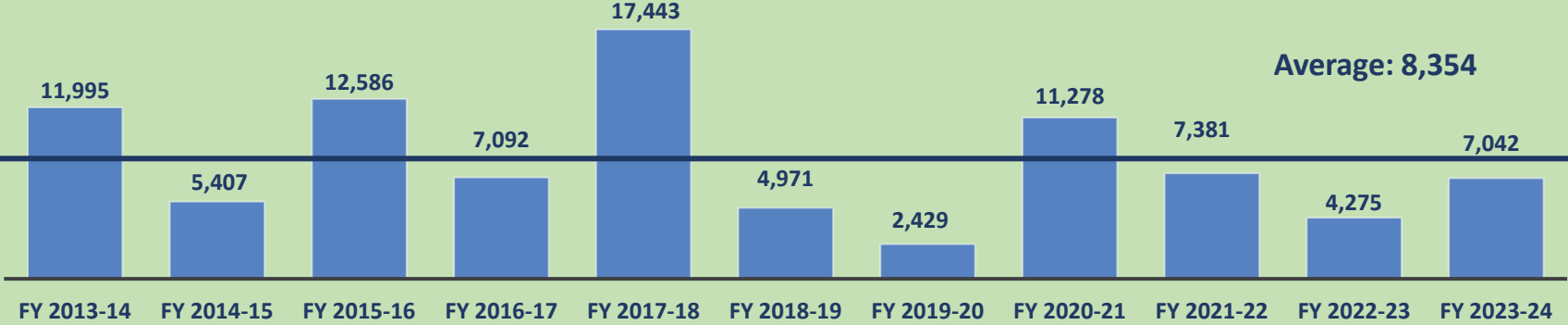

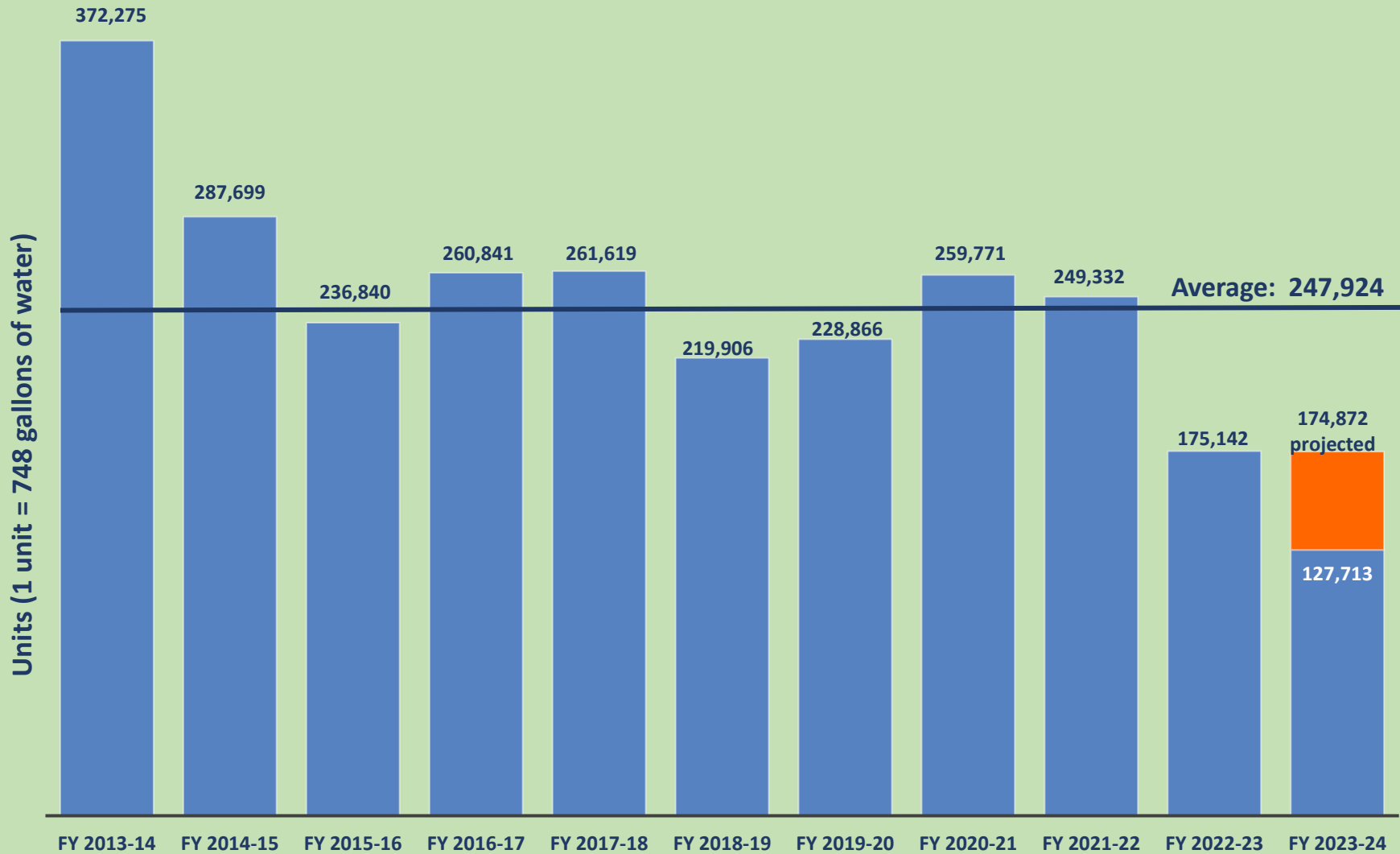
Historical Water Usage for December

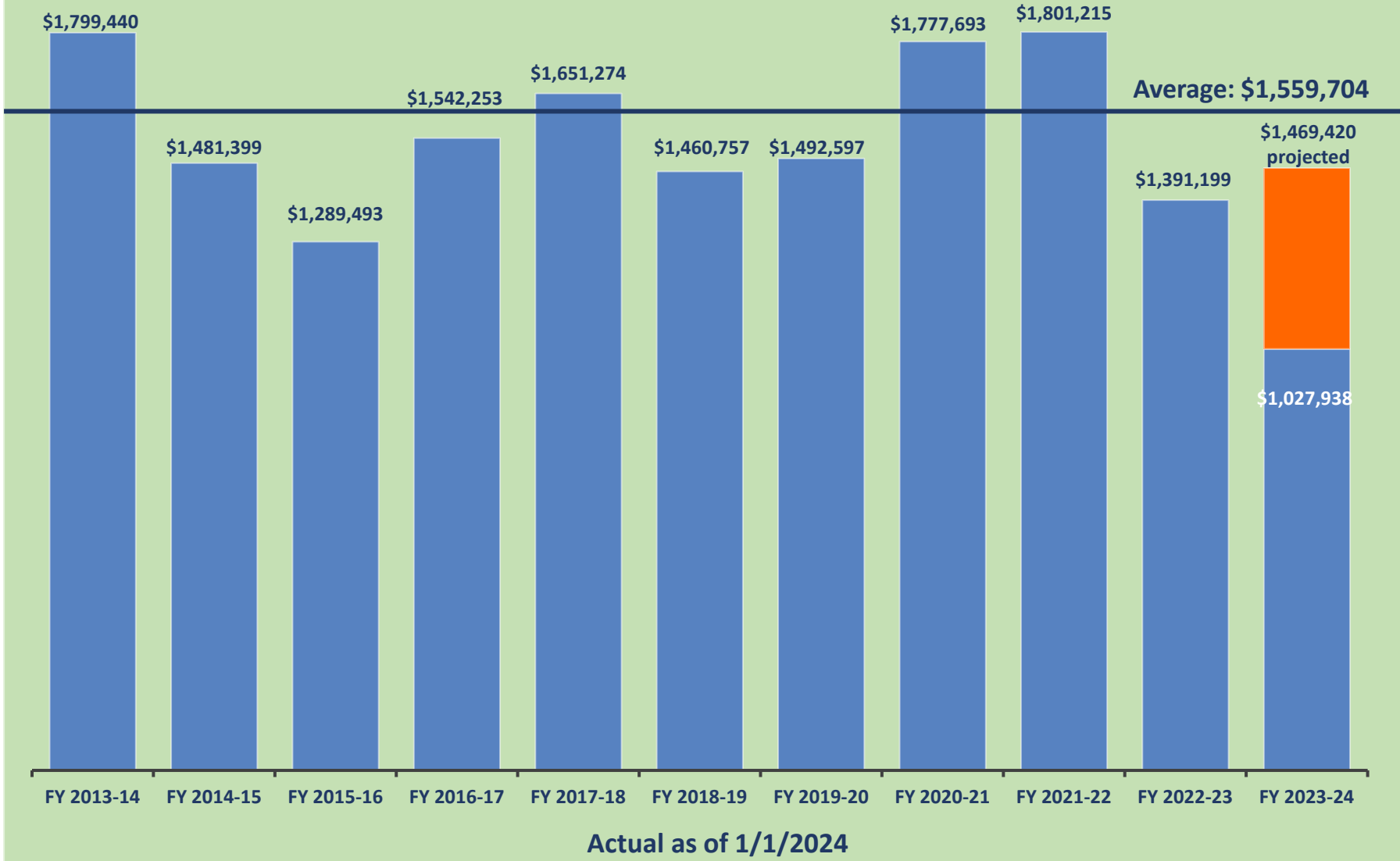
Historical Water Usage By Fiscal Year
